Charity Committee Recommends Donation to Elaine Clark Center and Mary's Shelter

The Charity Review Committee met on Tuesday, May 24 to consider two requests for Charitable Donations. This committee reviews requests submitted by Brother Knights and makes a recommendation that is voted on at the next meeting - in this case June 7. The requests - and the recommendation of the Committee are: 1. Tom Scherrer requested funds for the Elaine Clark Center to provide equipment and education activities for the special children that they assist. - Recommended \$1100; 2. Jack Klapka requested funds for Mary's Shelter - a halfway house for Unwed Mothers located in Orange Beach, Alabama. The K of C council at the St.

Thomas by the Sea Parish in Orange Beach is sponsoring the building of this facility, which suffered a large set back when Hurricane Ivan hit the area. These funds will go towards continuing the building process. - Recommendation \$1000.

There is a defined set of Charitable Organization Selection Procedures and Guidelines that has been in effect for several years. They can be accessed through the Council Web Site (www.kc11402.org) or can be obtained from the new Deputy Grand Knight. Charity is one of the cornerstones of the Knights of Columbus, so we invite your participation in this program.

Thanks to all those brothers who saw needs and brought them to our attention. We were able to allocate over \$5000 to needy causes over the past 12 months.
