# Grand Knight's Report

#### Brothers,

Autumn has yet to officially commence, but your council is already planning a full Fall schedule of activities, and they are even grander than normal.

For the first time, we are partnering with the All Saints Adult Education Department to bring the young fathers of the council and the parish an eightpart seminar on model Christian Fatherhood.

This new series is based on the <u>Fathers for Good</u> program of our own Knights of Columbus that was very recently featured on the April cover of our

very own <u>Columbia</u> Magazine. See the *www.fathersforgood.org* web site and the detailed article in this newsletter.

Our new audio/visual equipment will be professionally employed for pure educational purposes for the first time. We also hope to program presentations for prospective candidates and review DVDs we receive from Supreme about initiatives of the Order.

On Saturday morning, September 12th, All Saints becomes the center of the Georgia KofC universe, as we host the

first 3rd Degree Exemplification of the 2009-2010 Fraternal Year in Georgia at our Social Hall.

Last year we hosted about 120 candidates and 80 observers. This year we expect even more, and the entire Georgia Council Staff will be here and hold their own official meeting afterward on our site. Our council has 34 members that now qualify to receive their 3rd Degree. We hope they do so.

Ten days later on Tuesday, September 22nd, we have a 1st Degree scheduled in McGivney Hall. Should we be fortunate enough to induct eight new brothers, we will hit the magic 300-member plateau to establish 11402 as a major national council.

Just after those two exemplifications, we have been invited to participate for the first time in a *KofC Soccer Challenge* event on Saturday, September 26th, at the field of Holy Cross Council #10355. Located conveniently just off Chamblee-Tucker Road, a mile outside the Perimeter, all boys and girls aged 10 to 14 may compete at this facility. Their folks will in turn compete this winter in our Free Throw Tournament. We have a gym, they have a field. Sounds like another great partnership.

Dinner at Altobeli's Italian Restaurant will be held on September 20th. The event is nearly sold out.

October features our *Knights of Columbus 2nd Annual Columbus Day Golf Classic* on the 12th, again at beautiful Horseshoe Bend Country Club. We have decided to co-celebrate the Columbus Day

> holiday of our namesake with date and name of our tournament for this year and future years. We need more sponsors.

Our Oktoberfest Picnic will be held again on a Sunday to be determined upon site availability. This event is always my personal favorite of the year.

On a somber note, our Memorial Mass for Deceased Knights on Wednesday, October 21st, has two more names with the passing of Brothers Bill Lehman and Owen McCabe. **Memento Mori**.

Assuming that our current 122 members of the 3rd Degree will be increased by the grand events of September 12th, we hope to flood the ballroom of the Atlanta Airport Westin Hotel on November 7th with a record number of our 4th degree candidates.

This will be the last opportunity in this fraternal year to become a Sir Knight in Atlanta. Last year we had eight candidates. This year dare we hope for twenty? Information packets will soon be prepared.

Then November 20th, Lord willing and permits in hand, we have Monsignor's approval to hold what may be called *Monte Carlo Charity Knight* in the All Saints Social Hall. Not having attempted this before, we are asking those with any experience with any such gaming to step forward to make the night a success. You always do.

# Council Night at Altobeli's Italian Restaurant

We will be able to accommodate a maximum of 48 people in a reserved area of tables within view of the entertainment. A special menu with special pricing has been arranged to make the evening economical, delicious, and fun.

We will offer a choice of the 3 entrees shown below on the sample menu. The attendees do "NOT" have to make their selection until the night of the dinner.

To keep the price reasonable, we did not include a dessert, since we suspect that the majority of older folks do not order



desserts late. After dinner drinks may be purchased additionally from the bar and are not included.

There is always entertainment scheduled on Sunday evening, and we will have that enjoyment at no additional cost.

The price for this enjoyable evening will be only \$30.00 per person which INCLUDES TAX & TIP.

Those on that list can only be accommodated when cancellations are received.

We might want to point out that one complementary glass of wine (red or white) will be offered to each attendee, but they can purchase additional wine or spirits from the bar or by giving a credit card to the waiter. We do not wish to run a tab and then try to get the money from each Knight later. Your \$30 per person check should suffice for the base meal with no surprises.

As always, the group started and ended each day with the Lauds and Vespers prayers recited daily by our religious. Discussion sessions began with an examination of our mature concepts of God, to the role that sin plays in our lives, to forgiveness as exemplified in the Prodigal Son parable, to the existence of two competing standards in the modern world. Benediction, confession, and an evening Mass celebrated by our own brother, Father Bryan Small, topped off the first day.

Of special note this year, was the addition of seven brothers from outside our council who are members of our Fr. Charles J. Watters Assembly. We hope to expand the attendance each year to include brothers from all councils in the area. This was an excellent start in that regard.



## **Continuing Charitable Benevolence Efforts**

Our council benevolence continued at the August Business Meeting and during the entire month:

- The Charity Review Committee's recommendation to donate **\$1,000** to the Missionaries of the Poor in Jamaica was passed.
- The Council paid for the annual Altar Server Outing at the Malibu Gran Prix Center. The amount was just under **\$800.** "Thank you" received.
- A Speaker from the City of Dunwoody requested a donation to the fund to install a defibrillator in every police car. We voted **\$250**. A motion by Deacon Ray to buy one for our hall for **\$1,500** is pending a vote at September meeting.
- The Charity Review Committee reported favorably on a donation of **\$1,500** to the general fund of the Sister Sullivan Center. The issue passed.
- The council voted **\$200** for the purchase and logo printing of T-shirts for our Habitat House build later this year.
- The council passed the **\$1,000** donation request to Birthright. Picture in this newsletter showing presentation to Director Terry Weaver.
- The council passed a donation of **\$500** to the Friends of Disabled Adults and Children (FODAC).
- The council passed a budget not to exceed **\$250** for the creation of the "Knights of Crowlumbus" scarecrow to be displayed at the Atlanta Botanical Garden in October.
- The council passed a preliminary budget of **\$250** to be used for supplementing baby sitting services for knights to attend council functions that they would not be otherwise able to attend without such services.
- The council hosted a welcome cookout for returning students at the Emory Catholic Center for Fr. Bryan Small.
- The council hosted a welcome cookout for returning high school students of All Saints at McGivney Hall.
- Several brothers continued their **4th degree Honor Guard** activities. A significant honor guard for deceased brother Owen McCabe was undertaken per family request.
- Our ceremonial team again contributed time and talent at a 2nd degree exemplification at St. Brigid on August 20th.
- The council underwrote all costs for the Annual Summer Retreat not covered by attendee donations.

During the next few months, local Brothers will have the opportunity to advance to various degrees within the Order. First, third, and fourth degree exemplifications will be held at convenient times and locations to take members to the highest levels to which they may aspire.



Other candidates will be charged \$5 and all observers will be charged \$10 for the prime rib lunch we will serve. Coat and tie required.

**<u>1st Degree Exemplification</u>** — will be held on at 7:30 PM on Tuesday, **September 22nd**, in the All Saints McGivney Hall. Candidates should arrive at 6:45 PM. Coat and tie are requested, since pictures are always taken. Light refreshments will be served.

## KofC Soccer Challenge on Agenda for First Time

The Knights of Columbus have for some years sponsored a *Fall Soccer Challenge Tournament* event across the country. Our council has not participated because of the lack of a local soccer field that could be used. Our sister council Holy Cross 10355 in Chamblee has reserved such a field and invited other local councils to participate.

Holy Cross Church is located just off Chamblee-Tucker Road about a mile north of I-285 and is very convenient to us.

Since Holy Cross Council 10355 has a soccer field and no gym and our council has a gym and no soccer field, a partnership was a "no brainer," They in turn will attend our *Winter Basketball Foul Shooting Tournament*. Holy Cross Council recently was


This section of the KofC Soccer Challenge Manual gives the synopsis of just how the event works.

The Soccer Challenge is similar to the foul shooting event in that each youngster gets to kick a certain number of foul shots at the goal. Age group winners advance to district shootouts and then to state finals. Call Lou Hlad at 770-394-6327 or send email to *louhlad@bellsouth.net* if you have a youngster 10 to 14 years of age who is interested in participating. Bring proof of age and a parent signature will also be needed.

#### COMPETITION

The Knights of Columbus Soccer Challenge is a competition designed for players to demonstrate the most basic of soccer skills — the penalty kick. Each player will be allowed fifteen shots at the goal from the penalty line (12 yards from the goal).

The goal will be divided into a series of 5 scoring zones. The upper corners of the goal will be designated as 20 point zones. The lower corners will be designated as 10 point zones and the central region is a five point zone. To construct the five scoring zones attach a piece of rope approximately six and a half to seven feet in length diagonally across the four corners of the goal as shown in the diagram below. Use tent stakes to secure the bottom ropes to the ground.



#### SCORING

To score this competition each participant will be given 15 penalty kicks. Points will be awarded depending upon the area of the scoring zones through which the ball passes. For example, after the player's fifteen penalty kicks, his/her scores are 5/10/20/5/5/5/10/10/5/20/5/10/5/5, his/her total score would be 125. A score of 125 would be marked on the entry form/score sheet. Normal rules of soccer regarding penalty kicks apply for all levels of competition. Penalty kick violations include stepping on or over the line prior to the kick, and any contact made with

the ball counts as a kick. Scorers should record shots made and missed according to the instructions on the entry form/score sheet. It is also recommended that multiple scorers be assigned to each goal for scoring accuracy and comparison. All scores should be verified before the next contestant is allowed to shoot. The use of video tape recording is not recommended to resolve questions on scoring totals. Judges and scorers are given final authority in verifying all scores and violations.
