## **Elections Scheduled for June Meeting**




Any 3rd degree or greater brother is eligible for any elected office. It is time to be considering your greater participation in the management of the council and its direction.

# **\$7.6M construction project** begins at Brook Run Park

A major construction project at Dunwoody's largest park is set to begin today. the city said.

At Brook Run Park, officials plan to add two sports fields, a large lawn with a performance stage, a covered picnic pavilion and a nine-hole disc golf course, the city said in a statement Monday.

The 110-acre park at 4770 N. Peachtree Road currently has a large playground, a 2-mile-loop multi-use trail, a skate park, a dog park, a community garden and there could be temporary event pavilions.

The Duriwoody City Council approved the \$7.58 million overhaul in December. The project is expected to be completed in early 2020. Brook Run Park will remain open throughout the renovations, although



closures of some features.

"After seeking an enormous amount of public input and developing two park master plans, we're excited to start transformational improvements at Brook Run Park," Dunwoody Parks Director Brent

Walker said in the statement.

## Dunwoody paper bought by local media company

A family-owned media group that owns several local newspapers on metro Atlanta's Northside announced over the weekend it is acquiring Dunwoody's recently shuttered paper.

The Crier announced on April 9 that it was shutting down after 46 years, due in part to declining advertising revenues and a shrinking staff, Appen Media Group, which owns four weekly newspapers in North Fulton and Forsyth counties. announced April 19 it is acquiring The Crier, It's the first newspaper that Appen Media has bought, Hans Appen, the company's general manager, said in an interview.

"We're looking forward to being a part of the Dunwoody community. We're going to be learning more about what makes it tick as we go," he said.

The details of the sale were not released.

Currently, Appen Media owns the Alpharetta-Roswell Herald, Forsyth Herald, Johns Creek Herald and Milton Herald, as well as the monthly Northside Woman

magazine and a quarterly community guide. "Print newspapers are

still the heart and soul of what we do," Appen said.

The company plans to continue distributing The Crier weekly to 18,000 households. With the latest acquisition, Appen Media will have a distribution of 93,000.


"Our veteran reporters will continue their work," current Crier Publisher Dick Williams said in a statement.

Appen said he would like to continue expanding the company's reach in metro Atlanta, but the company is not currently eyeing any other markets. The family-owned business has been around for more than 30 years.

"It's kind of the opposite of the trend we're seeing," Appen said, referencing the high number of local newspapers that have been bought up by national investment companies in recent years.

More than a third of all newspapers have changed ownership over the last decade, according to research from the University of North Carolina last year. Even more troubling, almost 1,800 local newspapers have closed since 2004.

## 2018 Dues are Now Due (that's why they call them "Dues")

Our council <u>kc11402.org</u> web site handles electronic payment of council dues. You go to that web site, choose "Pay Dues", and you are connected to the PayPal system. You, of course, must have an active independent PayPal account already set up that is directed either to your check book or a credit card for debit purposes.

You may then pay your dues online for \$41.50 (which includes a \$1.50 electronic processing fee) by using your PayPal account to debit either a stated credit card or an amount directly out of your chosen checking account just like a debit card does.. Your personal PayPal account must be set up independently. There is a new second line choice that allows you to set up automatic \$41.50 PayPal payments for 5 years.

Of course, you may still pay your normal <u>2018 annual dues</u> of \$40 directly at a meeting or send a \$40 check made out to "KofC Council 11402" to our Financial Secretary, Dan McDonough at 6230 Blackberry Hill, Peachtree Corners, GA 30092. His email is <u>dmcd88@bellsouth.net.</u>

If a member is less than 26 years old on December 31, 2018, annual dues are only \$20. If you are a designated "Honorary" member (65 years old and a Knight for 25 <u>consecutive</u> years), your dues are only \$10. Priests, deacons, or members of a religious order pay no dues. Anyone who has been a Knight for 50 <u>unbroken</u> years likewise pays no dues. This year the Order has decided that Seminarians who join the Knights pay no dues as well.

These above rules are for Council 11402 dues only. <u>Watters 4th Degree Assembly dues of \$30 are separate.</u> We could not make it easier to pay your dues. Dues are assessed each January 1st.

# **ONLINE Membership Push**

Supreme is strongly pushing ONLINE membership as a quick doorway into KofC membership for reluctant joiners. Any practicing Catholic male who is interested in joining the Knights, but never pulled the trigger, can join <u>online</u> and then move at his own speed to council membership via 1st degree exemplification later.

An online member is a full member getting all magazines, electronic info, and a membership card, but not assigned to a council. Online membership is \$30. He can come to meetings if he chooses, but not vote. He can purchase KofC insurance. His info is sent to a local council for follow-up. If and when he decides to join a council, he is fully vetted, goes through a 1st degree, and his online membership data and initiation fees are forwarded to his council of choice. This process makes it easy for reluctant joiners to ease into council membership as time and schedule permits.

Millions of men are interested in the KofC, but feel they don't have the time to become active council members because of travel or family concerns. Tell your reluctant friends that these excuses have just disappeared.





# **Military Service Requirements**

Trey Gowdy, a former South Carolina Congressman, responded to a question from a CNN reporter about the ban of transgenders from joining the U.S. armed forces. As Trey typically does so very well, he nailed it rather succinctly

Question: How can our country claim to represent all U.S citizens, regardless of sexual orientation, when we banned transgenders from joining the military? Isn't that discrimination?

Trey Gowdy's Response:

"Nobody has a right to serve in the Military. Nobody! What makes you people think the Military is an equal opportunity employer? It is very far from it - and for good reasons - let me cite a few"

"The Military uses prejudice regularly and consistently to deny citizens from joining for being too old or too young, too fat or too skinny, too tall or too short. Citizens are denied for having flat feet, or for missing or additional fingers." he went on to explain: "By the way, poor eyesight will disqualify you, as well as bad teeth. Malnourished? Drug addiction? Bad back? Criminal history? Low IQ? Anxiety? Phobias? Hearing damage? Six arms? Hear voices in your head? Selfidentification as a Unicorn? Need a special access ramp for your wheelchair?"

"Can't run the required course in the required time? Can't do the required number of push-ups? Not really a morning person? and refuse to get out of bed before noon? All can be legitimate reasons for denial"

"The Military has one job: Winning War. Anything else is a distraction and a liability. Did someone just scream? That isn't Fair? War is VERY unfair, there are no exceptions made for being special or challenged or socially wonderful." "YOU must change yourself to meet Military standards and not the other way around."


"I say again: You don't change the Military - you must change yourself. The Military is not about being fair, it is about taking advantage of others and about winning.


